This contract is for all supply, delivery and assembly of material necessary for the above-referenced project at Facility No. 1, 3445 St. Lawrence Drive, Toledo, OH 43605, in accordance with the approved plans and specifications, for the Toledo-Lucas County Port Authority at One Maritime Plaza, Toledo, OH 43604.

Bids will be received at the Port Authority's administrative offices at One Maritime Plaza, Toledo, OH 43604 until Friday, February 12, 2010, at 2:00PM, at which time and place all bids will be publicly opened and read aloud.

The delivery address is 3445 St. Lawrence Drive, Toledo, OH 43605. This project consists of furnishing, delivering and assembling one (1) mobile ship loading conveyor to load vessels and barges, and also to stockpile bulk materials at the site. Mobility on site will require an undercarriage with axles for transport, radial travel, and lateral travel. The unit will be capable of handling bulk products serving the agricultural, mining, construction aggregate, power producing, and steel producing industries at loading and stockpiling rates of 1500 TPH, based on 100 PCF bulk density. The Engineer's Estimate for the supply and delivery is \$350,000.00.

Plans, Specifications, Instructions to Proposers, and Forms of Proposal and Contract are on file at the office of the Toledo-Lucas County Port Authority, One Maritime Plaza, Toledo, OH 43604 and may be obtained during normal business hours. The plans will also be on file in the plan room of McGraw-Hill Construction-F.W. Dodge.

Proposals must be submitted on the form included in the Specifications and shall be accompanied by a certified check or an acceptable Proposal Bond with satisfactory surety specifying the Toledo-Lucas County Port Authority as the obligee, in the sum of not less than ten percent (10%) of the total proposal amount.

Any bid may be withdrawn prior to the scheduled closing time for receipt of bids.

The successful bidder will be required to submit a Contract Bond, Maintenance Bond, and Certificate of Insurance.

The lowest responsive and responsible bid shall be determined in accordance with the Port Authority's Resolution No. 68-00 as found in the General Conditions.

The Port Authority reserves the right to reject any or all bids, and to waive any technicalities as it may deem best for their interest. The Port Authority also reserves the right to add or subtract from quantities shown in the proposal.
